B. FACILITY USE POLICY

Baldwin presented a revised draft of a possible policy and Gonzalez presented for the Director's and Board's consideration the Beloit Public Library's policy document regarding Canvassing and Selling in the Library. The Director has also questioned the Fort Worth and other public libraries regarding their policies on this subject and presented their

input. Baldwin will further revise the submitted policy for the Board's future consideration. No action was taken.

C. FY 2004 - 2005 BUDGET

Baldwin presented the documents BENBROOK LIBRARY DISTRICT PROPOSED BUDGET FOR FISCAL YEAR 2004-05, Option A (No Salary Increase & No Added Staff) and Library Director's Explanation of Proposed Changes For the 2004/05 Budget, as well as various tables of information regarding BLD sales tax revenue and the effect of possible salary increases on the budget. Following discussion, this item was tabled for further discussion at the next regular meeting.

D. LIBRARY FACILITY

The Board agreed to "reactivate" the Building Committee composed of Mike Baldwin, Dave Gattis, Jean Sherwin and Dave Wasson and to add to the committee a member with expertise in the area(s) of architecture/construction. The Board also received through Baldwin a proposal from Maureen Arndt at PSA Architects regarding cost of serving as Consulting Architect to the BPL Board for programming and preliminary design of the BPL Expansion. No action was taken.

A. BOB OLMSTEAD RESIGNATION

Due to his coming retirement and moving out of state on September 01, Olmstead submitted to the Board his resignation to be effective immediately following the Board meeting of August 09, 2004.
