#### B. ED PENNINGTON - ACCOUNTING UPDATE

Pennington recommended and the Board concurred that the date of transfer of funds from the District's checking account to the Texpool investment account be changed from the 15th of the month to the 25th of the month. This will avoid the possibility of showing a deficit in the checking account during those months having greater expenses.

## C. INITIATE FY 2003-2004 BUDGET PROCESS

The Director presented to the Board four budget proposals for the coming fiscal year: Option A, with no salary increase & no added staff; Option B, with no salary increase & adding one half-time clerk; Option C, with 3% salary increase & current staff only; and Option D, with 3% salary increase & adding one half-time clerk. The Board will review these options. No action was taken.

## D. CONSIDER REVISIONS TO DISTRICT'S MATERIALS CIRCULATION POLICY

The Director presented for the Board's review a revised Benbrook Library District Circulation Policy. No action was taken.
