VII. OLD BUSINESS

A. INCLEMENT WEATHER/EMERGENCY ACTION POLICY

Motion (Gonzalez), second (Olmstead), carried (unanimous) to accept as written the Director's proposed Policy on Unscheduled Closings Due to Inclement Weather or Other Emergencies.

B. AMEND BUDGET

Baldwin submitted his recommendation that the Board approve the following budget item adjustments: (1) "Audio Visual" from \$3,000 to \$7,000 (+\$4,000); (2) "Books" from \$50,000 to \$47,000 (-\$3,000); and "Shelving & Furnishing" from \$1,000 to \$0 (-\$1,000). Motion (Sherwin), second (Gonzalez), carried (unanimous) to approve the adjustments to the budget as recommended by the Director.

C. LIBRARY ADDITION/MARKETING/MAINTENANCE

Nothing new was reported concerning future Library addition. The marketing review process went very well. Mayor Hebert was very supportive of the Library during that process. Sherwin noted that exterior wood trim on the Library needs painting and some maintenance, and the Director will get an estimate for possible work in that regard.

A. FINANCIAL OFFICER TRAINING

Gonzalez will attend the next training session in August. Board President Heyser suggested that Olmstead also attend for cross-training purposes.
