I. CALL TO ORDER

IV. Approval of meeting minutes of April 16, 2012.

The minutes of the meeting of the Board held April 16, 2012 were distributed. A motion was made by Corky and second by Manny that we accept the minutes as written, motion carried (unanimous).

V. Reports

A. Report by James Blake, CCMI on Library expansion.

Blake gave a report on the possible sites for the Library expansion. He talked with Ron Rainey, Mike Baldwin and Steve Clegg to get information. One of the sites was the vacant Albertsons building off Hwy 377 which is not pedestrian friendly. The Trails near the river is another possibility, He asked for any feedback from the board and said he would be glad to help in any way he could. Manny made the comment that he couldn't see any advantage to going all the way to the back of the Trails to build a Library.

B. Library Director's and Assistant Director's report for April, 2012.

A copy of each report was emailed to each Board member. Julie asked about the Volunteer Dinner and it was reported that everything went very well. Manny asked about BRIT, it is the Botanical Research Center and Library on plants. Robert read a thank you note from one of the volunteers, Linda, about how she appreciated the dinner and the Board. Steve answered questions from the Board about the OverDrive meeting he attended.

C. Investment Officer, Report of Status for the District's Investments as of April 30, 2012. Manny asked about a set amount being deposited to TexPool each month. He thinks that the Board voted on this in the past. Robert asked Mike to look at the by-laws and see if he can find this. Corky talked with someone that worked at Compas Bank he met. This man told him that all pre-paid penalties should be put in the contract; the one with Frost bank does not have one noted.
