#### Α. LIBRARY DIRECTOR

Baldwin submitted the Library Director's Report for October, 2001 which listed these activities (summary):

>Public relations: provided Chamber of Commerce with forms related to the Library to include in newcomer packets; wrote articles for the News & Star about Roxanne Hoyt's receiving

the NTRLS award; drafted second newsletter to be published in November.

>Spoke with: representative of the BWSA about future expansion of parking lot and possibility of joining their health insurance group; Benbrook City Comptroller concerning State's 3-year retroactive adjustment of sales tax revenue which resulted in providing increased revenue to the District; District's auditor to arrange annual audit in November; sign designer to obtain estimates.

>Met with: Bob Olmstead to re-format Treasurer's Report; representatives of PLANT at its conference October 24-26.
>Set up new listserv for Texas Public Library Taxing District interest group; oversaw entering of titles into MetroPac catalog.

#### A. LIBRARY SIGN

#### B. EMPLOYEE INSURANCE

Baldwin presented the document Director's Recommendation On Group Insurance for Fiscal 2001/02. Motion (Sherwin), second (Olmstead), carried (unanimous) to approve the Director's recommendation as presented. Due to rate increases, the District's annual expense for group insurance will increase by \$614.52. Employees will be responsible for new and increased co-pay items.

### C. REVIEW ACCOUNTING SERVICES CONTRACT

As requested by the Board, Baldwin reviewed Ed Pennington's contract after five months and has determined that his services have proven to be very helpful to the District. He recommended that the District continue to contract with Pennington for accounting services at the current rate of \$250.00 per month. Motion (Ziehe), second (Olmstead), carried (unanimous) to approve the Library Director's Recommendation On Accounting Services as presented.

### A. LIBRARY NEWSLETTER

Baldwin presented a draft of the second Benbrook Public Library newsletter which will be mailed to each household in the city before Christmas. It includes an opinion survey on Library services.

Baldwin showed the excellent PowerPoint presentation on the importance of librarianship that he developed and presented at the annual PLANT conference which was held at Garrett Creek Ranch October 24 - 26.

The request to join Tex-Share has been sent in, but no reply has been received yet. The Director will check on this.

VII. PUBLIC COMMENT - Opportunity to express concerns/comments to the Board

Roxanne Hoyt updated the Board on the planned annual Volunteer Appreciation Dinner which will be given by the Friends of the Benbrook Public Library and held at Spring Creek Barbecue on December 3.
