- III. Approval of Meeting Minutes Regular Meeting on Monday, September 18<sup>th</sup> and Special Meeting on Friday, September 22<sup>nd</sup>

Starting October 1, 2024, the PTO will move into per pay period accrual only. Rachel seconded the motion. All ayes confirmed motion approval.

Rachel moved to restrict the 40 frontloaded PTO hours. If an employee terminates their employment, they will pay back whatever is left of the frontloaded PTO on a quarterly basis. Larry seconded the motion. The four ayes and one nay confirmed motion approval and approval of the PTO restriction.
